

The All4Knox Recovery Housing Guide was designed to help our community partners more easily navigate Recovery Housing options within and around the Knoxville area. While every effort was made to provide the most current information, you are encouraged to contact specific housing programs for further questions and to confirm other details. Please note that this guide is intended to compile multiple recovery housing programs for potential consideration and is not intended to serve as a referral system. #### Third-Party Approvals and Accreditations

Most houses on this list have pursued third-party approvals and/or accreditations to varying degrees from local agencies or state entities. This specifically refers to three entities and processes:

- Accreditation from the **Tennessee Alliance of Recovery Residences (TNARR)**, our state affiliate for the National Alliance of Recovery Residences (NARR).
- Approval from the Tennessee Department of Correction (TDOC), which is subject to change on a monthly basis.
- Approval from Metro Drug Coalition (MDC) through participation in their Recovery Housing Support Fund.

Houses with TNARR accreditation, TDOC approval, and/or MDC approval will have a 📀 in the appropriate column.

#### **Special Populations**

If a housing program has services designed specifically for special populations, it will be noted as such (e.g. for veterans only, faith-based, etc.). Some programs may have the capacity to serve multiple special populations. Populations include:
