

All4Knox Recovery Housing Guide

The All4Knox Recovery Housing Guide was developed to help community partners more easily navigate recovery housing operations in and around the Knoxville area. While every effort has been made to ensure the information is current, readers are encouraged to contact individual housing programs directly to confirm details and address specific concerns. This guide is intended to compile recovery housing programs that have operational oversight by a third party for informational and consideration purposes only. It is not intended to function as a referral system. The guide is updated on a quarterly basis, and the most current version is available on the All4Knox website: www.All4Knox.org/resources/.

Third-Party Approvals and Accreditations

The housing programs listed have pursued third-party approvals and/or certifications through local agencies or state entities. This includes the following three entities and processes:

- Certification from the **Tennessee Alliance of Recovery Residences (TNARR)**, our state affiliate for the National Alliance of Recovery Residences (NARR).
- Approval from the **Tennessee Department of Correction (TDOC)**, which is subject to change on a monthly basis.
- Approval from **Metro Drug Coalition (MDC)** through participation in their Recovery Housing Support Fund.

Houses with TNARR certification, TDOC approval, and/or MDC approval will have a in the appropriate column.

Special Populations

If a housing program offers services designed specifically for certain populations, this will be noted accordingly (e.g. veterans, faith-based). Some programs may have the capacity to serve more than one population. Populations include:

If a housing program accepts residents who are receiving Medication-Assisted Treatment (MAT) or are in Medication Assisted Recovery (MAR), the specific medication(s) accepted will be listed. Some programs may require prescriptions to be stored and/or managed by program staff. Medications include:
